# Nicola Lake Planning Process 2013/14 - Q4 Final Report to March 31, 2014

# **Overview**

The focus of efforts in the fourth quarter, January 1, 2014 to March 31, 2014, include meeting with the Nicola Lake Steering Committee (NLSC) and continuing to implement the action items in the Nicola Lake Action Plan (the Plan).

This report includes three sections: 1) a progress summary of activities completed in the reporting period, 2) a financial status for the three month period and fiscal year, and 3) a preview of planned activities for the next quarter, April 1 to June 30, 2014.

The next report will be provided in July 2014 for activities in Q1 of 2014/15.

# **1. Progress Summary**

This progress summary describes the major activities that took place during the reporting period.

# **Planning & Administration**

- Application for summer student funding through the Canada Summer jobs program
- Application for Interior Salish Employment and Training Society (ISETS) funding for summer students in cooperation with the Nicola Tribal Association
- Submitted application for \$25 000 to World Wildlife Fund "Community Water Fund" not approved
- Coordination and facilitation of NLSC meetings
- Website maintenance <u>www.nicolaplan.ca</u>
- Communication with all orders of government (including first nations), stakeholders, interest groups

The following is the status of the actions associated with each of the goals identified in the final version of the Nicola Lake Action Plan, dated June 20, 2013.

# Goal 1 – Control Invasive Species in Nicola Lake

- Request for proposals drafted and sent out to contractors for the fisheries utilization assessment
- Proposals were received and reviewed for the fisheries utilization assessment; the contract was awarded to Trinton Environmental Consultants Ltd.
- Met with representatives from the Ministry of Transportation and Infrastrucuture regarding permission for roadside signs

# Goal 2 – Improve or maintain water quality in Nicola Lake

- Ongoing water quality monitoring and data collection by the Nicola Lake Stewardship Society volunteers, in cooperation with Ministry of Environment
- Shoreline erosion control work at Monck Park is now complete

# Goal 3 – Education and Awareness

- Development of Education and Awareness Outreach Technician job description and advertisement of the positions
- Working toward having local Girl Guides (or other group) plant trees at Monck Park

# Goal 4 - Sustainably manage multiuse lake recreation

• The recreation survey report (Nicola Lake and Area Recreation Survey Report) is complete and available on the the Nicola Lake webpage

# Goal 5 - Sustainably manage lakefront and foreshore development

• There has been no development on this goal during the third quarter – education around forshore development will be included in the outreach information delivered this summer by Outreach Technicians

# 2. Financial Status

- Sample invert species in EWM infested areas that have been identified for selective diver removal (2014) to help determine the effect(s) that EWM removal may have on invert populations (Thompson Rivers University honours student thesis)
- Communicate with potential contractors for EWM control work, and explore operations experience with Columbia Shuswap Regional District, Okanagan Basin Water Board, and the TNRD
- Hire summer students to operate mobile boat wash station around Nicola Lake and area to raise awareness about aquatic invasive species and preventing their spread

#### Goal 2 – Improve or maintain water quality in Nicola Lake

- Collect data and draft a public report on water quality in Nicola Lake
- Identify significant sediment sources in Nicola Lake and tributaries

### Goal 3 – Education and Awareness

- Develop education and information, media releases, and awareness of the plan and actions
- Print and install invasive species signage at designated locations at Nicola Lake
- Hire summer students to deliver information on education objectives listed in the Plan, around Nicola Lake and area
